We'll also get any spots too narrow or steep for a mower to reach. After we finish mowing, edging, and trimming, we will blow off all hard surfaces such as driveways, sidewalks, and more even if we didn't get anything on them. We'll also let you know if we noticed any areas of concern: signs of lawn disease, possible pest infestations, weed encroachment, etc.

In addition, we'll bag excess clippings if we can tell that's going to be the case even if you didn't specifically request that. We'll always use a bagger around objects you don't want debris on, like outdoor tables and benches your employees enjoy lunch at on nice days. As we mow, we take care to pass in consistent patterns that leave the grass with a well-tailored look, not as if someone took a random approach to it.
